

"ASABE MEMBER OF THE YEAR"

PURPOSE:

To recognize an individual whose career accomplishments, activities and high standards best exemplify the goals of the Agricultural Engineering profession in the Quad City Section and whose support, participation and leadership in ASABE have contributed to the advancement of the Society and the betterment of the profession.

SELECTION CRITERIA:

1. The candidate's contributions to the Agricultural Engineering profession through career accomplishments in such areas as design and research, education, demonstrated leadership and/or services rendered as shown either through participation in professional societies or other organizations.
2. Promotion of ASABE through participation and leadership in both the local and national organization.
3. Contributions toward social betterment through service in and support of civic, service and religious organizations.
4. The candidate must be a member of the Quad City Section of ASABE.
5. Nominations for this award will be considered for two additional years if not selected in the initial year.

NOMINATING PROCEDURE:

This process includes preparation and submission of a nomination petition. Guidelines for the petition are listed on the back of this form. Petitions must be completed and mailed (to David Smith, 120 39th Avenue, East Moline, IL 61244) or emailed (to dave.smith8633@sbcglobal.net) by March 1, 2018.

AWARD ADMINISTRATION:

Award administration is the responsibility of the Local Awards Member Service Area of the ASABE Quad City Section. This includes soliciting nominations and preparing the award certificate. Nominees will be screened and the recipient selected by the Section's Executive Committee.

The award will consist of a certificate with the award title, recipient's name and year of presentation. The award presentation will be made at the Awards Meeting of the Quad City Section of ASABE currently scheduled for March 27, 2018.

Nominees for this award may also be submitted, at the discretion of the Local Awards Committee, as ASABE Quad City Section candidates for additional local and national awards.

Guidelines for Nominating Petition

PART I (Required) Statement of Nomination

1. Date
2. Candidate's Full Name, title, employer and mailing address.
3. Statement of nomination: Not more than two typewritten pages. Supported by scope and nature of professional achievements, ASABE participation, and character of the candidate both professional and personal.

PART II (Provide as much information as possible) Personal and Professional Credentials

1. Education: schools and degrees.
2. Professional record in chronological order: employers, positions, and responsibilities.
3. Membership and activities held in scientific and/or honorary societies.
4. Honors and awards received.
5. Patents, publications, design accomplishments, etc.: list most important accomplishments.
6. Membership and activities in social, civic, service, fraternal and religious organizations.

PART III (Required) Sponsor Identification

1. Name, business and email address and phone number of nominator.
